BY THE COMMISSION:

On February 1, 2022, the Nebraska Public Service Commission (“Commission”) initiated this proceeding on its own motion to implement the Nebraska Broadband Bridge Act (“the Act”) and administer the 2022 grant cycle of the Nebraska Broadband Bridge Program (“NBBP”). In this docket, on December 6, 2022, the Commission entered an order issuing grant awards and the results of challenges (“Dec. 6 Order”).

Pursuant to the Dec. 6 Order, projects awarded in the 2022 NBBP grant cycle were required to be completed by June 6, 2024. As set forth in the Act, as modified by LB 1144 (2022), awardees could be permitted extensions of the project deadline for good cause shown. Following completion of the project, awardees were required to submit a certification that the broadband network described in the application was completed. Within thirty days of project completion, awardees were required to submit speed testing results demonstrating that the locations served by the project could be served at a minimum of 100/100 Mbps speeds.

Grant awards were issued on a periodic basis, with 25% distributed at the time of project award and 25% distributed in the ninth month following the grant award. The remaining 50% of the grant award was distributed to awardees upon successful completion of the project and speed testing, and upon review of submitted invoices to justify expenses. Final award payments were adjusted based upon actual eligible project costs and match percentage.

All outstanding projects awarded in the 2022 NBBP grant cycle have now been completed, and final reimbursements have been issued. A summary of projects completed pursuant to the 2022 NBBP grant cycle is attached to this order as Attachment A. As no funding remains available for distribution in this grant cycle, the Commission finds that this docket should be closed.
