By application filed on April 10, 2008, SoundBite Communications, Bedford, Massachusetts, seeks authority to register the connection of an automatic dialing-announcing device to a telephone line.

Applicant is a corporation, with its headquarters located in Bedford, Massachusetts, whose mailing address is 22 Crosby Drive, Bedford, Massachusetts. Applicant proposes to connect a NMS model #80298 automatic dialing-announcing device located at Ashburn, Virginia.

Having reviewed the matter, the Commission finds that the application complies with the applicable statutes and Rules and Regulations of the Commission regarding automatic dialing-announcing devices.

IT IS FURTHER ORDERED that this order be, and it is hereby, made the Commission's official registration as set forth in this order and shall remain in force and effect for two years from this date unless used in a manner inconsistent with state or federal law.

IT IS FURTHER ORDERED that, upon receipt of this order and prior to connecting the device to any telephone line, the applicant shall notify the serving telephone company in writing of its intent to connect or operate such device and identify the line to which connection is proposed.

IT IS FURTHER ORDERED that Applicant notify the Commission of any changes in the information contained in its application within five days.

IT IS FURTHER ORDERED that Applicant notify the Commission of any changes in the information contained in its application within five days.


