By application filed on October 21, 2008, National Enterprise Systems, Inc. (Applicant), Solon, Ohio, seeks authority to register the connection of an automatic dialing-announcing device to a telephone line.

Applicant is a corporation, incorporated in the State of Ohio, whose mailing address is 29125 Solon Road, Solon, Ohio, 44139. Applicant proposes to connect an Ontario Systems/NMS/Adtran, model NMS-2035-51047, Adtran 1202.0664 automatic dialing-announcing device located at 6230 Cochran Road, Solon, Ohio.

Having reviewed the matter, the Commission finds that the application complies with the applicable statutes and Rules and Regulations of the Commission regarding automatic dialing-announcing devices.

IT IS FURTHER ORDERED that, upon receipt of this order and prior to connecting the device to any telephone line, the applicant shall notify the serving telephone company in writing of its intent to connect or operate such device and identify the line to which connection is proposed.

IT IS FURTHER ORDERED that Applicant notify the Commission of any changes in the information contained in its application within five days.



IT IS FURTHER ORDERED that Applicant notify the Commission of any changes in the information contained in its application within five days.


