## O P I N I O N      A N D      F I N D I N G S

By application filed on March 23, 2010, Meridian Central Public Affairs, LLC (Applicant), Omaha, seeks authority to register the connection of an automatic dialing-announcing device to a telephone line.

Applicant is a limited liability company, whose mailing address is 2937 South 120<sup>th</sup> Street, Omaha, Nebraska 68144. Applicant proposes to connect a Proprietary Platform of Broadnet automatic dialing-announcing device located in Denver, Colorado.

IT IS FURTHER ORDERED that, upon receipt of this order and prior to connecting the device to any telephone line, the applicant shall notify the serving telephone company in writing of its intent to connect or operate such device and identify the line to which connection is proposed.

IT IS FURTHER ORDERED that Applicant notify the Commission of any changes in the information contained in its application within five days.


