By application filed on August 16, 2011, Victory Enterprises, Inc. (Applicant), Davenport, Iowa, seeks authority to register the connection of an automatic dialing-announcing device to a telephone line.

IT IS FURTHER ORDERED that Applicant notify the Commission of any changes in the information contained in its application within five days.






