By application filed on July 26, 2012, Connectel Inc., Fremont, California, seeks authority to register the connection of an automatic dialing-announcing device to a telephone line.

IT IS FURTHER ORDERED that Applicant notify the Commission of any changes in the information contained in its application within five days.
