## OPINION AND FINDINGS

By application filed on January 23, 2014, Meridian Central Public Affairs, LLC, (Applicant), of Omaha, Nebraska, seeks authority to register and connect an automatic dialing-announcing device located in Dallas, Texas, to a telephone line.

Applicant is a limited liability company located in the State of Nebraska, whose mailing address is 2937 South 120<sup>th</sup> Street, Omaha, Nebraska 68144. Applicant proposes to connect a Broadnet Proprietary automatic dialing-announcing device in Dallas, Texas.

Having reviewed the matter, the Commission finds that the application complies with the applicable statutes and Rules and Regulations of the Commission regarding automatic dialing-announcing devices.

## ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. AD-571r be, and it is hereby granted, and Meridian Central Public Affairs, LLC, be, and is hereby authorized to connect an automatic dialing-announcing device in accordance with its application, the Nebraska Statutes and the Rules and Regulations of this Commission.

IT IS FURTHER ORDERED that this order be, and it is hereby, made the Commission's official registration as set forth in this order and shall remain in force and effect for two years from this date unless used in a manner inconsistent with state or federal law.

IT IS FURTHER ORDERED that, upon receipt of this order and prior to connecting the device to any telephone line, the Applicant shall notify the serving telephone company in writing of its intent to connect or operate such device and identify the line to which connection is proposed.

IT IS FURTHER ORDERED that Applicant notify the Commission of any changes in the information contained in its application within five days and script changes within twenty-four hours.
