## O P I N I O N     A N D     F I N D I N G S

By application filed on April 1, 2014, Genesys Telecommunications, Inc., Daly City, California, seeks authority to connect an automatic dialing-announcing device to a telephone line.

Applicant is a corporation, with its headquarters located in Daly City, California, whose mailing address is 2001 Junipero Serra Blvd., Daly City, CA 94014. Applicant proposes to connect a session border controllers (SBC) NexTone-high capacity telephone switch automatic dialing-announcing device located in Somerville, Massachusetts.

Having reviewed the matter, the Commission finds that the application complies with the applicable statutes and Rules and Regulations of the Commission regarding automatic dialing-announcing devices.

IT IS FURTHER ORDERED that Applicant notify the Commission of any changes in the information contained in its application within five days.
