By application filed on July 7, 2015, Tele-Town Hall, LLC (Applicant), of Arlington, Virginia, seeks authority to register and connect an automatic dialing-announcing device located in Des Moines, Iowa.

Applicant is a limited liability company whose mailing address is 4600 Fairfax Drive, Suite 802, Arlington, VA 22203. Applicant proposes to use a Digium Inc., Model Asterisk 11.4.0 dialing-announcing device.

Having reviewed the matter, the Commission finds that the application complies with the applicable statutes and Rules and Regulations of the Commission regarding automatic dialing-announcing devices.

IT IS FURTHER ORDERED that, upon receipt of this order and prior to connecting the device to any telephone line, the Applicant shall notify the serving telephone company in writing of its intent to connect or operate such device and identify the line to which connection is proposed.

IT IS FURTHER ORDERED that Applicant notify the Commission of any changes in the information contained in its application within five days and script changes within twenty-four hours.


