## O P I N I O N     A N D     F I N D I N G S

By application filed on February 1, 2016, Meridian Central Public Affairs, LLC, (Applicant), of Omaha, Nebraska, seeks authority to register and connect an automatic dialing-announcing device located in Las Vegas, Nevada, to a telephone line.

Applicant is a limited liability company located in the State of Nebraska, whose mailing address is 18331 Dupont Circle, Omaha, Nebraska 68130. Applicant proposes to connect a Broadnet Proprietary automatic dialing-announcing device in Las Vegas, Nevada.

Having reviewed the matter, the Commission finds that the application complies with the applicable statutes and Rules and Regulations of the Commission regarding automatic dialing-announcing devices.
