By application filed on December 4, 2017, Victory Phones, LLC, (Applicant), Grand Rapids, Michigan, seeks authority to register the connection of an automatic dialing-announcing device utilizing a Voice over Internet Protocol platform (VoIP) leased through Rackspace Cloud Hosting.

Applicant is a Corporation located in the State of Michigan, whose mailing address is 190 Monroe Ave. NW Ste. 300, Grand Rapids, Michigan 49503. Applicant proposes to utilize a software based automatic dialing device.

Having reviewed the matter, the Commission finds that the application complies with the applicable statutes and Rules and Regulations of the Commission regarding automatic dialing-announcing devices.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. AD-646r be, and it is hereby granted, and Victory Phones, LLC, be, and is hereby authorized to connect an automatic dialing-announcing device in accordance with its application, the Nebraska Statutes and the Rules and Regulations of this Commission.

IT IS FURTHER ORDERED that this order be, and it is hereby, made the Commission's official registration as set forth in this order and shall remain in force and effect for two years from this date unless used in a manner inconsistent with state or federal law.
