OPINION AND FINDINGS

By application filed on August 29, 2018, Convoso, Inc. (Applicant), of Woodland Hills, California, seeks authority to register and connect an automatic dialing-announcing device located in Los Angeles, California, to a telephone line.

Applicant is a corporation located in the State of California, whose mailing address is 5955 DeSoto Ave., Ste. 210, Woodland Hills, California 91367. Applicant proposes to connect a custom built Convoso technology based automatic dialing-announcing device in Los Angeles, California.

Having reviewed the matter, the Commission finds that the application complies with the applicable statutes and Rules and Regulations of the Commission regarding automatic dialing-announcing devices.

IT IS FURTHER ORDERED that Applicant notify the Commission of any changes in the information contained in its application within five days.

IT IS FURTHER ORDERED that in accordance with 291 Neb. Admin. Code § 11-004.06, Applicant shall file with the Commission any scripts it intends to use within twenty-four hours of beginning to transmit the message, and include with such filing the registration number of Applicant's device transmitting the script, the date the script first began to be transmitted, and an electronic audio file indicating the run time of the message.
