Applicant seeks to revise its tariff relating to Connection of Customer Provided Equipment based on recent changes in the Federal Communications Commission Registration Program. It is also proposed to add the Institutional Program for Premises Wiring where customers provide the wiring. A charge of \$26.50 for the first 15 minutes and \$6.50 for each additional 15 minutes would apply for telephone company testing of such wiring.
