OPINION AND FINDINGS

BY THE COMMISSION:

By its application filed July 3, 1980, the General Telephone Company of the Midwest, Columbus, Nebraska, seeks authority to establish 4-party service and 1-party zoned service for rural customers in a portion of the Leigh, Nebraska exchange.

Notice of the filing of the application was published pursuant to the provisions of the Commission's Rules and Regulations. No protest to the application was filed.

Applicant proposes to furnish 1-party and 4-party service in a portion of the Leigh rural area in place of the present multi-party service. Petitions expressing desire for the improved service were signed by 98% of the subscribers affected.

Applicant's present rate for business multi-party service is \$8.20 per month, and for residence multi-party service \$4.85 per month at its Leigh exchange. The proposed one party service is to be furnished by zones, the first two being approximately two miles each in width and the third zone comprising the balance of the exchange. Proposed rates are as follows:

Business 1 party	\$12.10	\$14.10	\$16.10
Residence 1 party	7.70	9.70	12.70
Residence 4 party	6.00	6.00	6.00

The present multi-party service would be discontinued when facilities for the improved services become available.

The proposed rates for zoned service as set forth above are less than rates computed using mileage charges in each of the three zones.

Upon consideration of the application and attending circumstances and being fully advised, the Commission is of the opinion and finds that the application is fair and reasonable, is in the public interest and should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-39 be and it is hereby granted and the General Telephone Company of the Midwest, Columbus, Nebraska, be and it is hereby authorized to furnish 4-party service and zoned 1-party service in a portion of the Leigh exchange as set forth in the Opinion and Findings, which by this reference is made a part hereof.
