OPINION AND FINDINGS

BY THE COMMISSION:

By its application filed November 10, 1980, the Northwestern Bell Telephone Company, Omaha, Nebraska, seeks approval to revise its General Exchange and Private Line Tariffs.

Notice of the filing of the application was published pursuant to the provisions of the Commission's Rules and Regulations. No protest to the application was filed.

Applicant seeks to withdraw from its tariff regulations and rates approved in Application No. C-21. These tariffs have not yet been put into effect. They would comply with FCC Rules and Regulations's permitting registration of terminal equipment and systems for direct connection to certain private line services.

Upon consideration of the application and attending circumstances and being fully advised, the Commission is of the opinion and finds that the application is fair and reasonable, is in the public interest and should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-99 be and it is hereby granted and the Northwestern Bell Telephone Company, Omaha, Nebraska be and it is hereby authorized to revise its tariff to include the sheets set forth in the Opinion and Findings herein.

IT IS FURTHER ORDERED that applicant file appropriate tariff sheets with the Commission.
