OPINION AND FINDINGS

BY THE COMMISSION:

By its application filed December 29, 1980, the Hooper Telephone Company, Hooper, Nebraska, seeks approval of tariffs.

Notice of the filing of the application was published pursuant to the provisions of the Commission's Rules and Regulations. No protest to the application was filed.

Attached to the application and incorporated herein by reference is a copy of applicant's proposed tariff consisting of the following parts:

Section I	Definitions
Section II	General Rules and Regulations
Section III	General Exchange Service Tariffs
Section IV	Local Exchange Service Tariffs
Section V	Message Toll Telephone Service Tariffs

The proposed tariff contains regulations governing the furnishing of telephone service by applicant and conforms with regulations approved by this Commission for other telephone companies.

The tariff also contains rates and charges for local service and miscellaneous services which rates and charges have been approved by this Commission in previous applications.

Applicant proposes to establish rates and charges for new services and equipment not presently offered including lighted dial instruments, fire reporting equipment, touch tone instruments, automatic dialers, key equipment, speaker phones and electronic secretaries.

Increases in rates for the following items of equipment are proposed:

Upon consideration of the application and attending circumstances and being fully advised, the Commission is of the opinion and finds that the application is fair and reasonable, is in the public interest and should be granted.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-113 be and it is hereby granted and the Hooper Telephone Company, Hooper, Nebraska be and it is hereby authorized to revise its tariff to include the sheets set forth in the Opinion and Findings herein.
