OPINION AND FINDINGS

BY THE COMMISSION:

COMMISSIONERS CONCURRING:

Pursuant to Commission order entered October 20, 1981, the Northwestern Bell Telephone Company, Omaha, Nebraska, has submitted for the Commission's approval a schedule of rates and charges for telephone service that will produce additional intrastate annual revenue of \$7,129,006.

The Commission has examined the schedule of rates and charges and finds that it should be modified as set forth on schedule A, attached hereto and incorporated herein by reference.

Present and allowed rates by rate groups are set forth on Schedule B attached hereto and incorporated herein by reference.

Applicant will submit tariff sheets incorporating all of the changes proposed.

Premises considered, the Commission is of the opinion and finds that the schedule of rates and charges for telephone service including local exchange service set forth on attached Schedules A and B are fair and reasonable and should be granted to become effective on November 1, 1981.
