OPINION AND FINDINGS

BY THE COMMISSION:

By application filed October 13, 1981, the Tracy Corporation, dba KMOR, Scottsbluff, Nebraska, seeks authority to provide radio common carrier service.

A letter of protest to the application was filed on November 13, 1981 by United Telephone Company of the West.

On December 15, 1981, applicant submitted a Motion for Production of Documents and Information which requested that the protestant be ordered to produce the information set forth below by mailing it to applicant's attorney on or before December 31, 1981:

The documents requested are for the years 1980 and 1981 for one way paging service and two way radio common carrier service.

1. Applications of customers filed with United Telephone system; and
2. Waiting list of customers waiting for service, broken down by months, setting forth customers' names and addresses; and
3. The number and nature of service interruptions, broken down by months; and
4. Held applications; and
5. Trouble reports; and
6. Customers' complaints pertaining to any service, said complaints being comprised of letters, phone calls, written memorandum, etc.; and
7. Records of applications for service which were denied or for which service was denied and the reasons therefor; and
8. The financial report filed with the Nebraska Public Service Commission on or before April 30, 1980 and 1981 for the succeeding (sic) year.

Upon consideration of the motion and attending circumstances and being fully advised, the Commission is of the opinion and finds that the motion should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Motion for Production of Documents and Information in Application No. C-187 be and it is hereby granted.
