OPINION AND FINDINGS

BY THE COMMISSION:

By its application filed December 10, 1981, The Lincoln Telephone and Telegraph Company, Lincoln, Nebraska, seeks authority to revise its General Exchange Tariff.

Notice of the filing of the application was published pursuant to the provisions of the Commission's Rules and Regulations. No protest to the application was filed.

Applicant seeks to revise its tariff to offer jacks for two and three line sets and a 15 watt paging speaker. It is also proposed to increase rates for transistorized headsets and headset jacks and personal radio paging service. Applicant also seeks to discontinue the offering of 10 watt speakers, weatherproof telephone housings and transaction telephones and to eliminate the limit on the number of directories furnished. It is also proposed to revise and clarify the provisions relating to circuits associated with customer-owned communication systems, trunk line Touch Call charges and recording telephone conversations.

Applicant's proposed tariff revision would provide that the beep tone would not be required if all parties "consent to the elimination of the tone". It appears that the proposed language is not appropriate and this provision should be denied.

Upon consideration of the application and attending circumstances and being fully advised, the Commission is of the opinion and finds that the application is fair and reasonable, is in the public interest and as modified above should be granted in part.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-210 be and it is hereby granted in part and The Lincoln Telephone and Telegraph Company be and it is hereby authorized to revise its tariff to include the sheets set forth in the Opinion and Findings herein.

IT IS FURTHER ORDERED that the revision of the tone warning provision be and it is hereby denied.

IT IS FURTHER ORDERED that applicant file appropriate tariff sheets with the Commission.
