Applicant seeks to revise its tariff to restructure the existing Dimension rate elements by separating the existing Basic Common Equipment into two separate rate elements: Basic Common Equipment and Basic Control Carrier. Two new Dimension service are to be offered. Prelude PBX and Energy Communications Service Adjunct.
