OPINION AND FINDINGS

BY THE COMMISSION:

By its application filed July 29, 1982, Tracy Corporation II, Scottsbluff, Nebraska, seeks authority to acquire the Certificate of Tracy Corporation.

Notice of the filing of the application was published pursuant to the provisions of the Commission's Rules and Regulations. No protest to the application was filed.

Pursuant to notice required by law, public hearing was held on the application on October 19, 1982, at 8:00 a.m. in the Commission Hearing Room, Lincoln, Nebraska with appearance as set forth above.

Upon consideration of the application, the evidence adduced at the hearing and being fully advised, the Commission is of the opinion and finds that:

- l. Applicant, Tracy Corporation II, is a corporation organized and existing under the laws of the State of Nebraska with its principal place of business at Scottsbluff, Nebraska.
- 2. Tracy Corporation is a corporation organized and existing under the laws of the State of Nebraska with its principal place of business at Scottsbluff, Nebraska.
- 3. Michael J. Tracy and his wife are the sole stockholders of both Tracy Corporation and Tracy Corporation II. Tracy Corporation was granted a Certificate of Convenience and Necessity authorizing it to operate as a radio common carrier in Scotts Bluff County. Said Certificate was granted by this Commission in application No. C-187 on May 17, 1982.
- 4. This application was filed in order that the radio common carrier operation be performed by a corporation separate and apart from Tracy Corporation which is also engaged in other activities.
- 5. The application is fair and reasonable, is in the public interest and should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-289 be and it is hereby granted and Tracy Corporation II be and it is hereby authorized to acquire the Certificate of Convenience and Necessity issued to Tracy Corporation.
