OPINION AND FINDINGS

BY THE COMMISSION:

By its application filed January 31, 1983 ATS Mobile Telephone Inc., of Omaha, Nebraska seeks approval for emergency rates for certain paging services.

Applicant alleges that because the rates approved by the Commission in Application No. C-314 of the Northwestern Bell Telephone Company are less than applicant's presently authorized rates for paging service that it is not able to compete with Northwestern Bell Telephone Company. Applicant further alleges that it has lost paging subscribers to Northwestern Bell Telephone Company and will continue to do so unless it is allowed to file bulk rates immediately.

Applicant proposes the following rates for direct dial interconnected paging services:

Applicant's proposed Direct Dial Digital Display Paging Service is the subject of Application No. C-339 upon which a public hearing is scheduled. The proposed localized services are new services not presently offered by the applicant.

Upon consideration of the application and attending circumstances and being fully advised, the Commission finds that as to rates for Direct Dial Interconnected Tone-Only Paging Service, an emergency does exist as provided by Section 75-121, R. R. S. 1943, and the application should be granted in part. Emergency rates proposed for other services should be devised.


ORDER


IT IS FURTHER ORDERED that that part of the application not approved on an emergency basis shall be processed as a normal application.
