OPINION AND FINDINGS

BY THE COMMISSION:

By application filed August 5, 1983, Nielsen Communications, Inman, Nebraska seeks a Certificate of Public Convenience and Necessity.

Notice of the filing of the application was published pursuant to the provisions of the Commission's Rules and Regulations. A protest to the application was filed by Union Telephone Company.

Pursuant to notice required by law, public hearing was held on the application on November 9, 1983 at 9:30 a.m. in the Courthouse, Center, Nebraska with appearance as set forth above.

Upon consideration of the application, the evidence adduced at the hearing and being fully advised, the Commission is of the opinion and finds that:

1. Applicant is a sole proprietorship owned by Norman Nielsen. He is presently engaged in sales and servicing of two-way radios and pagers at Inman, Nebraska.

2. Mr. Nielsen testified on behalf of the applicant. He plans to install a tower and base station at Bloomfield, Nebraska to provide two-way mobile radio service as a radio common carrier within a 25 mile radius.

3. Following the hearing, applicant amended its application to eliminate the offering of paging service, at which time the protest of Union Telephone Company was withdrawn.

4. Mr. Nielsen holds an FCC Second Class General Radio License and is qualified technically and financially to operate the proposed RCC system.

5. Mr. Nielsen testified that he had been contacted by approximately 30 individuals expressing an interest in two-way mobile service.

6. The application, as amended, is fair and reasonable, is in the public interest and should be granted as amended.

IT IS FURTHER ORDERED that this order be and it is hereby made the Commission's official Certificate of Public Convenience and Necessity to provide the service authorized herein.
