OPINION AND FINDINGS

BY THE COMMISSION:

Pursuant to Commission order entered June 25, 1984 the Continental Telephone Company of Nebraska, Wisner, Nebraska, has submitted for the Commission's approval a schedule of rates and charges for telephone service that will produce additional annual revenue of \$535,184.

Proposed monthly exchange rates and rate groups are set forth on Appendix A attached hereto and incorporated herein by reference. Tariffs submitted including miscellaneous rates are also incorporated herein by reference.

The Commission has examined the schedule of rates and charges and tariffs and finds that they conform to the order entered June 25 1984.

Premises considered, the Commission is of the opinion and finds that the schedule of rates and charges for telephone service as set forth on Appendix A are fair and reasonable, are in the public interest and should be granted to become effective July 4, 1984.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission pursuant to the original order entered in Application No. C-434 on June 25, 1984, that applicant be and it is hereby authorized to charge and collect the rates set forth in Appendix A attached hereto and by reference made a part hereof, effective July 4, 1984.

IT IS FURTHER ORDERED that applicant file appropriate tariff sheets with the Commission.

IT IS FURTHER ORDERED that all present rates and charges for telephone service not herein modified, revised or replaced be and shall remain in full force and effect.
