OPINION AND FINDINGS.

BY THE COMMISSION:

By application filed November 7, 1983, Nielson Communications, Inman, Nebraska, seeks a Certificate of Public Convenience and Necessity.

Notice of the filing of the application was published pursuant to the provisions of the Commission's Rules and Regulations. A protest was filed by Page-Comm of Norfolk but was subsequently withdrawn.

Pursuant to notice required by law, public hearing was held on the application on January 31, 1984 at 8:00 a.m. in the Commission Hearing Room, Lincoln, Nebraska.

Upon consideration of the application, the evidence adduced at the hearing and being fully advised the Commission is of the opinion and finds that:

- 1. Nielsen Communications is owned by Norman E. and Theresa M. Nielsen and has its principal place of business at Inman, Nebraska.
- 2. It is presently engaged in the sale and servicing of two-way radios and pagers. Applicant has also been authorized by this Commission to operate as a radio common carrier providing two-way mobile radio service within a 25 mile radius of Bloomfield, Nebraska.
- 3. Applicant now seeks to provide mobile radio and paging as a radio common carrier serving subscribers having businesses or residences located within the area of Antelope and Madison Counties in Nebraska presently served by General Telephone Company of the Midwest.
- 4. Applicant proposes to establish a transmitter site near Neligh, Nebraska to serve subscribers on UHF frequencies.
- 5. Applicant has received expressions of interest in the service proposed from 13 individuals.
- 6. Applicant should be limited to two years in which to have its system in operation.
- 7. The application is fair and reasonable, is in the public interest and should be granted.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that application No. C-470 be and it is hereby granted and Nielsen Communications be and it is hereby authorized to furnish two-way mobile radio and paging service as a radio common carrier to subscribers having businesses or residences in Antelope and Madison Counties, Nebraska in areas served by General Telephone Company of the Midwest.

IT IS FURTHER ORDERED that this order be and it is hereby made the Commission's Official Certificate of Public Convenience and Necessity to provide the service authorized herein.

IT IS FURTHER ORDERED that the authority granted herein shall expire two years from the date of this order in the event that applicant has failed to operate the service proposed, unless the Commission has, for good cause shown, granted an extension of time.
