Applicant seeks to revise its tariffs effective January 1, 1984 to discontinue references to terminal equipment in accordance with the Modified Final Judgement as ordered by the United States District Court for the District of Columbia in Civil Action No. 82-0192 and agreed to by AT&T and the Justice Department.

Upon consideration of the application and attending circumstances and being fully advised, the Commission is of the opinion and finds that the application is fair and reasonable, is in the public interest and should be granted.
