OPINION AND FINDINGS

BY THE COMMISSION:

By its application filed January 31, 1984, Page-Comm, Norfolk, Nebraska seeks a Certificate to provide one-way paging and mobile telephone service to subscribers in Platte County, Nebraska now being served by General Telephone Company of the Midwest.

Notice of the filing of the application was published pursuant to the provisions of the Commission's Rules and Regulations. No protest to the application was filed.

Pursuant to notice required by law, public hearing was held on the application on April 3, 1984 at 8:00 a.m. in the Commission Hearing Room, Lincoln, Nebraska.

Upon consideration of the application, the evidence adduced at the hearing and being fully advised, the Commission is of the opinion and finds that:

1. Applicant Page-Comm is the trade name of Chris A. and Sally J. Petersen, husband and wife, of Norfolk, Nebraska.
2. Mr. Petersen has had 17 years experience in the servicing and repair of mobile radio and paging equipment. He is an officer and stockholder of Mid-Nebraska Communications, Inc. which is engaged in the sale and servicing of Motorola communications equipment in Norfolk and Columbus, Nebraska. Mrs. Petersen has had 8 years experience as an employee of Mid-Nebraska Communications, Inc.
3. Page-Comm holds a certificate of public convenience and necessity to operate as a radio common carrier at Norfolk, Nebraska. Authority is now sought to provide paging and mobile radio service at Columbus, Nebraska to subscribers in Platte County who are served by General Telephone Company of the Midwest. Applicant intends to employ Mid-Nebraska Communications, Inc. as the repair and maintenance center for the Columbus area.
4. Financial statements attached to the application indicates that applicant is qualified to operate the system proposed.
5. Applicant should be allowed two years from the date of this order to have its system in operation, unless an extension of time is granted by the Commission.

6. The application is fair and reasonable, is in the public interest and should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that application No. C-488 be and it is hereby granted and Page-Comm be and it is hereby authorized to provide one-way paging and mobile telephone service to subscribers in Platte County, Nebraska within the area served by General Telephone Company of the Midwest.

IT IS FURTHER ORDERED that this order be and it is hereby made the Commission's Official Certificate of Public Convenience and Necessity to furnish this service proposed.

IT IS FURTHER ORDERED that this authority shall lapse two years from the date of this order in the event the proposed system is not in operation, unless such time be extended by the Commission.
