BY THE COMMISSION:

By its application filed February 10, 1984, the Northwestern Bell Telephone Company, Omaha, Nebraska, seeks approval of tariff sheets which comply with the Modified Final Judgement.

Notice of the filing of the application was published pursuant to the provisions of the Commission's Rules and Regulations. No protest to the application was filed.

Applicant seeks to revise its Mobile Telephone Exchange Service, Private Line Digital Service and Intrastate Private Line tariffs to comply with the Modified Final Judgement.

It is also proposed to revise the General Exchange Tariff to provide credits for Centrex and Centron subscribers paying interstate access charges.

Upon consideration of the application and attending circumstances and being fully advised, the Commission is of the opinion and finds that the application is fair and reasonable, is in the public interest and should be granted.
