OPINION AND FINDINGS

BY THE COMMISSION:

By its application filed January 29, 1985, the Eastern Nebraska Telephone Company, Blair, Nebraska, seeks to establish rates for custom calling features.

Notice of the filing of the application was published pursuant to the provisions of the Commission's Rules and Regulations. No protest to the application was filed.

Applicant seeks to revise its tariff to offer custom calling features including call waiting, three-way calling, call forwarding and revertive calling. At the present time custom calling features will be available only at the Walthill, Winnebago, Rosalie and Macy exchanges.
