OPINION AND FINDINGS

BY THE COMMISSION:

By its application filed July 16, 1985, the Omaha Cellular Limited Partnership, Centel Cellular, General Partner, Omaha, Nebraska, seeks authority to revise its tariff.

Notice of the filing of the application was published pursuant to the provisions of the Commission's Rules and Regulations. No protest to the application was filed.

Attached to the application and incorporated herein by reference are copies of the following proposed tariff sheets:

First Revised Sheets 11, 15-16, 18-23

Applicant proposes the following revisions in its tariff for cellular mobile telephone service:

- (a) to provide for customer payment responsibility for charges incurred from another cellular carrier on a roamer basis.
- (b) to revise the peak and off-peak period.
- (c) to change billing increments from one minute to one-tenth minute increments.
- (d) to establish and extend promotional rate plans on a non-discriminatory basis.
- (e) to revise the minimum number of access numbers under the multiple number plan from 10 to 5.
- (f) to extend a discount for custom calling features to bulk users of cellular service.
- (g) to discontinue hot line restriction service.
- (h) to establish a longevity discount based upon years of continuous service.

Upon consideration of the application and attending circumstances and being fully advised, the Commission is of the opinion and finds that the application is fair and reasonable, is in the public interest and should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-601 be and it is hereby granted and the Omaha Cellular Limited Partnership, Centel Cellular Company, General Partner, Omaha, Nebraska be and it is hereby authorized to revise its tariff to include the sheets set forth in the Opinion and Findings herein.

IT IS FURTHER ORDERED that applicant file appropriate tariff sheets with the Commission.
