OPINION AND FINDINGS

BY THE COMMISSION:

By application filed September 20, 1985, Golden West Telecommunications Cooperative, Inc., Wall, South Dakota seeks a Certificate of Convenience and Necessity to acquire the telephone exchange at White Clay, Nebraska.

Notice of the filing was published pursuant to the provisions of the Commission's Rules and Regulations. No protests were filed. The application was processed administratively on December 17, 1985.

Applicant is a cooperative association organized and existing under the law of South Dakota with its principal place of business at Wall, South Dakota.

The Extension Telephone Company of White Clay, Nebraska a mutual company has agreed to sell and applicant has agreed to purchase the telephone system at White Clay, Nebraska. Under the proposed acquisition the White Clay subscribers will be served from applicant's Pine Ridge, South Dakota exchange and all one party service will be provided. The following Pine Ridge rates will apply in the White Clay area: residence 1-party, \$6.05; farm or ranch 1-party, \$9.55; business 1-party, \$13.30.

Attached to the application is a map of the White Clay area showing the proposed subscribers and construction. This map corresponds to the existing White Clay exchange area.

The application is fair and reasonable, is in the public interest and should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that application No. C-610 be and it is hereby granted and Golden West Telecommunications Cooperative, Inc. be and it is hereby authorized to serve the area presently being served by the Extension Telephone Company.

IT IS FURTHER ORDERED that this order be and it is hereby made the Commission's official Certificate of Convenience and Necessity to serve said area.
