OPINION AND FINDING

BY THE COMMISSION:

By application filed November 6, 1985, the Omaha Cellular Limited Partnership, Centel Cellular, General Partner, Omaha, Nebraska, seeks authority to revise its tariff.

Notice of the filing of the application was published pursuant to the provisions of the Commission's Rules and Regulations. No protest to the application was filed.

Attached to the application and incorporated herein by reference are copies of the following proposed tariff sheets:

Second Revised Sheets 19 and 20 and Original Sheet 20.1

Applicant proposes the following revisions in its tariff for cellular mobile telephone service:

- (a) to create a new Standard Service Plan to provide access, five hours of usage (peak or off-peak) and custom calling features for \$99.95 per month, with provision for excess usage rates;
- (b) to clarify the applicability of service order charges upon conversion to the Standard Service Plan; and
- (c) to eliminate multiple prices for packaged peak usage under the Basic Service Plan.

Upon consideration of the application and attending circumstances and being fully advised, the Commission is of the opinion and finds that the application is fair and reasonable, is in the public interest and should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-616 be and it is hereby granted and the Omaha Cellular Limited Partnership, Centel Cellular Company, General Partner, Omaha, Nebraska be and it is hereby authorized to revise its tariff to include the sheets set forth in the Opinion and Findings herein.
