OPINION AND FINDINGS

BY THE COMMISSION:

By order entered January 6, 1987, the above-captioned application was granted in part and applicant was directed to submit for approval a schedule of rates to produce additional annual revenue of \$155,943.

Applicant has submitted its proposed rates which incorporate the findings of the January 6, 1987 order, including an EAS additive and the elimination of charges for touch tone service.
