Applicant seeks to revise its tariff to restructure rates for Sprint Advanced WATS service and to introduce Sprint Advanced WATS-2 service. The restructured rates will result in reduced mileage bands and reduced minimum and maximum rates. Sprint Advanced WATS-2 service is available is equal access areas and permits customers to access Sprint's facilities by Feature Group D connections rather than dedicated facilities.

Upon consideration of the application and attending circumstances and being fully advised, the Commission is of the opinion and finds that the application is fair and reasonable, is in the public interest and should be granted.
