OPINION AND FINDINGS

BY THE COMMISSION:

By application filed May 29, 1986, Omaha Cellular Limited Partnership seeks approval by this Commission of a revision in its Tariff Section 4.6 pursuant to Nebraska Revised Statutes, § 75-121 (Reissue of 1981). Upon review of the contents of the application, and being fully advised concerning this matter, the Commission finds that Applicant's Tariff Section 4.6 should be amended as set forth below in order that members of the general public in Applicant's service area will have the opportunity for more economical access to Applicant's services on the most expeditious basis, and that an emergency exists.

As amended, sub-sections (F) and (G) will be added to Section 4.b of Applicant's Tariff, such sub-sections to read as follows:

(F) Value Service Plan

Access rate per number, per month	\$34.95
Usage rate, per 1/10 minute	\$.025

(G) Dispatch Service Plan

Each Cellular Customer utilizing this plan is entitled to an unlimited number of messages up to 1/2 minute in duration at the flat per message rate stated below. All other calls will be chargeable in accordance with the per minute rates shown.

The Cellular Customer will be responsible for any land line carrier charges associated with calls placed under this plan.

Access rate per number, per month	\$34.95
Rate per message up to 1/2 minute in duration	\$.10
Usage rate per 1/10 minute for calls exceeding 1/2 minute in duration	
Peak Period	\$.040
Off Peak Period	\$.020


IT IS FURTHER ORDERED that applicant file appropriate tariff sheets with the Commission.


