OPINION AND FINDINGS

BY THE COMMISSION:

By application filed July 2, 1986, Omaha Cellular Telephone Company, a Nebraska partnership, Omaha, Nebraska seeks approval of a revision of its Tariff Sections V., G.; VI., C., 2.; VI., C., 2(e) and VI., C., 5(a) and (b), pursuant to Nebraska Revised Statutes Section 75-121 (Reissue 1981). A review of the application demonstrates that subscriber rates in no instance would be increased. A slight reduction in rates due to the manner of calculation of minutes of use may occur in some instances. Therefore, immediate benefit would be recognized by applicant's subscribers.

Applicant has indicated that it bills on a calendar month basis and a new software program has been developed for billing purposes. Implementation of the proposed revisions on an emergency basis would bring immediate benefit to subscribers and allow applicant to implement its new software program immediately. Being fully apprised of the facts concerning this matter, the Commission finds that applicant's tariff should be amended as set forth in the application and that members of the public in applicant's service area will have the opportunity for more economical access to applicant's service on the most expeditious basis, and that an emergency exists.

Applicant proposes to revise pages 13, 19, 20, 21 and 22 of its tariff so as to charge customers only for minutes of conversation on completed calls originated by cellular radio telephone unit; to change the definition of Frequent Caller Service to include three special features free of charge; to change the name of a service package from Quickline to Expressline; to add a footnote to exempt Frequent Caller Service from the one minute minimum and 1/10 minute increment provisions of the tariff; and to clarify footnotes.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-663 be and it is hereby granted and Omaha Cellular Telephone Company be and it is hereby authorized to revise its tariff as set forth in the Opinion and Findings herein effective in accordance with Section 75-121 of the Nebraska Revised Statutes, as amended.

IT IS FURTHER ORDERED that applicant file appropriate tariff sheets with the Commission.
