OPINION AND FINDINGS

BY THE COMMISSION:

By its application filed July 24, 1986, Midwest Communications, Inc., Grand Island, Nebraska, seeks approval of the acquisition of certain assets and the portion of the Certificate of Convenience and Necessity of Nebraska Radio Telephone Systems dealing with manual mobile Telephone Service only and Radio Paging Service in and around Grand Island, Nebraska.

Notice of the filing of the application was published pursuant to the provisions of the Commission's Rules and Regulations. No protests to the application were filed.

Applicant is a Nebraska corporation with its principal place of business located in Grand Island, Nebraska. All of the stock in Midwest Communications, Inc. is owned by Mr. and Mrs. James D. Roth, residents of Grand Island, Nebraska.

Applicant and Nebraska Radio Telephone Systems have entered into an agreement for the purchase by applicant of that part of the Nebraska Radio Telephone Systems business in Grand Island consisting of the manual mobile telephone service only, and the radio paging service as described in the agreement attached to the application and incorporated herein by reference.

Upon consideration of the application and attending circumstances and being fully advised, the Commission is of the opinion and finds that the application is fair and reasonable, is in the public interest and should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-667 be and it is hereby granted and that Midwest Communications, Inc. be and it is hereby authorized to acquire the manual mobile telephone service only and the radio paging service business of Charles P. Oden, doing business as Nebraska Radio Telephone Systems as set forth in the opinion and findings herein.


