OPINION AND FINDINGS

BY THE COMMISSION:

By application filed August 25, 1986, Chris A. Petersen and Sally J. Petersen doing business as Page-Comm of Norfolk, seek to transfer their Certificate of Convenience and Necessity to Telebeep, Inc.

Notice of filing of the application was published pursuant to the Commission's Rules and Regulations. No protest to the application was filed.

Pursuant to notice required by law, public hearing was held on the application on October 21, 1986, in the Commission Hearing Room, Lincoln, Nebraska.

Upon consideration of the application, the evidence adduced at the hearing, and being fully advised, the Commission is of the opinion and finds that:

1. Applicant, Page-Comm of Norfolk, is the trade name of Chris A. and Sally J. Petersen of Norfolk, Nebraska. It is engaged in the communications business as a radio common carrier in Norfolk under the jurisdiction of the Commission.

2. Applicant is incorporating its business as Telebeep, Inc. and seeks to transfer all of the certificates granted in Applications C-457, C-488, and C-594, to Telebeep, Inc.

3. There will be no actual change in management or operations as a result of this incorporation since Chris A. Petersen and Sally J. Petersen are Telebeep's total stockholders.

4. The application is fair and reasonable, is in the public interest, and should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-680 be and it is hereby granted and Chris A. Petersen and Sally J. Petersen, operating as Page-Comm of Norfolk, be and they are hereby authorized to transfer the Certificates of Convenience and Necessity to Telebeep, Inc.

IT IS FURTHER ORDERED that this order be and it is hereby made the Commission's Official Certificate of Convenience and Necessity to Telebeep, Inc., to provide radio common carrier service in the areas served by Page-Comm of Norfolk.




