OPINION AND FINDINGS

BY THE COMMISSION:

By its application filed November 17, 1986, Nielsen Communications, Inman, Nebraska seeks authority to extend its radio common carrier service area to include all points within 40 miles of Neligh, Bloomfield, O'Neill and Ainsworth, Nebraska.

Notice of the filing of the application was published pursuant to the provisions of the Commission's Rules and Regulations. Protests were filed by Northeast Nebraska Telephone Company, Rock County Telephone Company, Telebeep, Inc. and Ainsworth Communications.

Pursuant to notice required by law, public hearing was held on the application on February 19, 1987 at 1:30 p.m. in the Commission Hearing Room, Lincoln, Nebraska with appearance as shown.

Upon consideration of the application, the evidence adduced at the hearing and being fully advised, the Commission is of the opinion and finds that:

1. Applicant is a radio common carrier offering mobile telephone and paging service in and around Bloomfield, Nebraska.
2. Applicant seeks authority to provide radio common carrier service to all points within 40 miles of Neligh, Bloomfield, O'Neill and Ainsworth, Nebraska.
3. Norman Nielsen testified. He has had approximately 20 years experience in sales and servicing of two way radio equipment. He plans to offer a UHF mobile system with tower sites covering northeast Nebraska.
4. The evidence shows that applicant is fit, willing and able to provide the service proposed in its application.
