OPINION AND FINDINGS

BY THE COMMISSION:

By docket opened August 7, 1990, the Commission on its own motion seeks to determine the boundary between the Stanton exchange of the Stanton Telephone Company and the Clarkson exchange of US West.

Both the Stanton Telephone Company and US West were notified of this docket and directed to propose a revised boundary which will eliminate the duplicate service area.

Both telephone companies have agreed that part of the area in question should be included in the Stanton exchange of the Stanton Telephone Company and one customer, Curtis Koehn, should be allowed to continue to receive telephone service from the Clarkson exchange. Part of the area should be included in the Clarkson exchange of US West and one customer, Jim Scherer, should be allowed to continue to receive telephone service from the Stanton exchange. If the customer moves or sells the property or business or the existing service is disconnected for any other reason then new service must be provided solely by the company in whose exchange area the customer is located, the only exception being that service may be transferred to another family member who is a member of the household at that time.

Mr. Koehn and Mr. Scherer were notified of this proposal by certified mail on November 9, 1990, and given 30 days in which to request a public hearing. No response has been received.

Upon consideration of the docket and being fully advised, the Commission is of the opinion and finds that a boundary has been agreed upon by all parties which will eliminate the duplicate service area in question between the Stanton and Clarkson exchanges. Both telephone companies should be ordered to file revised service area maps showing the area in question and that Curtis Koehn be grandfathered to receive service from the Clarkson exchange and Jim Scherer be grandfathered to receive service from the Stanton exchange.


ORDER




