OPINION AND FINDINGS

BY THE COMMISSION:

By docket opened August 7, 1990, the Commission on its own motion seeks to determine the boundary between the Wisner exchange of Great Plains Communications and the Wayne exchange of US West.

Both Great Plains Communications and US West were notified of this docket and directed to propose a revised boundary which will eliminate the duplicate service area.

Both telephone companies have agreed that the area in question should be included in the Wayne exchange of US West and one customer, Stuthman Brothers, should be allowed to continue to receive telephone service from the Wisner exchange. If the customer moves or sells the property or business or the existing service is disconnected for any other reason then new service must be provided solely by US West, the only exception being that service may be transferred to another family member who is a member of the household at that time.

Stuthman Brothers was notified of this proposal by certified mail on March 12, 1991, and given 30 days in which to request a public hearing. No response has been received.

Upon consideration of the docket and being fully advised, the Commission is of the opinion and finds that a boundary has been agreed upon by all parties which will eliminate the duplicate service area in question between the Wisner and Wayne exchanges. Both telephone companies should be ordered to file revised service area maps showing the area in question to be in the Wayne exchange and that Stuthman Brothers be grandfathered to receive service from the Wisner exchange.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that a boundary be determined in docket No. C-854 which will eliminate the duplicate service area in question between the Wisner and Wayne exchanges.


