OPINION AND FINDINGS

BY THE COMMISSION:

By docket opened June 10, 1991, the Commission on its own motion seeks to determine the boundary between the Arlington exchange of the Arlington Telephone Company and the Fremont exchange of US West.

Both the Arlington Telephone Company and US West were notified of this docket and directed to propose a revised boundary which will eliminate the duplicate service area.

Both telephone companies have agreed that the area in question should be included in the Arlington exchange of the Arlington Telephone Company and one customer, Mr. Kevin Prinz, should be allowed to continue to receive telephone service from the Fremont exchange. If the customer moves or sells the property or business or the existing service is disconnected for any other reason then new service must be provided solely by Arlington Telephone Company, the only exception being that service may be transferred to another family member who is a member of the household at that time.

Mr. Prinz was notified of this proposal by certified mail on June 10, 1991, and given 30 days in which to request a public hearing. No response has been received.

The boundary revisions agreed upon require that Arlington Telephone Company be granted access through a portion of the US West Fremont exchange along Highway 91 in order to serve customers in its service area in Sections 5, 8, 28 and 29, Township 19 North, Range 9 East, Washington County.

Upon consideration of the docket and being fully advised, the Commission is of the opinion and finds that a boundary has been agreed upon by all parties which will eliminate the duplicate service area in question between the Arlington and Fremont exchanges. Both telephone companies should be ordered to file revised service area maps showing the area in question to be in the Arlington exchange and that Mr. Kevin Prinz be grandfathered to receive service from the Fremont exchange. Arlington Telephone Company should be granted access through a portion of the Fremont exchange to serve customers in its service area as set forth above.

ORDER


IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that a boundary be determined in docket No. C-890 which will eliminate the duplicate service area in question between the Arlington and Fremont exchanges.

IT IS FURTHER ORDERED that revised service area maps be filed by the Arlington Telephone Company and US West showing the area in question to be in the Arlington exchange with a note on the maps indicating that service to Mr. Kevin Prinz is grandfathered from the Fremont exchange.





