By its application filed October 7, 1991, Great Plains Communications, Inc., Blair, Nebraska seeks authority to authorize ten thousand (10,000) new shares of common stock for a total of twenty thousand (20,000) authorized shares of common stock, and to issue up to said twenty thousand (20,000) shares of common stock.

Notice of the filing of the application was published pursuant to the Commission Rules and Regulations. No protest to the application was filed, and the application was processed by modified procedure pursuant to Title 291, Chapter 1, Rule 018.03.

OPINION AND FINDINGS

BY THE COMMISSION:

Upon consideration of the application and attending circumstances, and being fully advised, the Commission is of the opinion and finds:

1. Applicant is a corporation, duly organized and existing under the laws of the State of Nebraska with its principal place of business at Blair, Nebraska.

2. Applicant is engaged in the telephone business as a common carrier serving approximately 25,500 access lines in approximately 51 exchanges in the state of Nebraska.

3. Applicant requests Commission approval to authorize ten thousand (10,000) new shares of common stock for a total of twenty thousand (20,000) authorized shares of common stock, and to issue up to the twenty thousand (20,000) shares of common stock. No voting rights of any of the classes of stock will be changed. The authorization of six thousand (6,000) shares of preferred stock would remain unchanged.

4. The proposed change will not result in cash proceeds to applicant.

5. The application is fair and reasonable, is in the public interest, and should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-904 be and it is hereby granted and Great Plains Communications is hereby granted approval to





