BY THE COMMISSION

Hooper Telephone Company ("Hooper") filed an application to open this docket June 2, 1992. Hooper seeks an order from the Commission altering the boundary between its exchange and the exchange of Northeast Nebraska Telephone Company ("Northeast"). Notice of the application was published in the Omaha Daily Record June 4, 1992 and was sent by first class mail to both parties by the Commission's Executive Director June 5, 1992. No protests to the application were received and the application will therefore be processed by modified procedure.

O P I N I O N A N D F I N D I N G S

In support of its application, Hooper alleges there is an apparent error in the boundary line between its Hooper exchange and Northeast's Craig exchange in Section 18, Township 20 North, Range 9 East, Dodge County, Nebraska as shown on Northeast's Craig exchange map (which is incorporated herein by reference as Exhibit A). Hooper further alleged it has served that particular area and has cable facilities in place.

Hooper proposed that the boundary in Section 18, Township 20 North, Range 9 East, Dodge County, Nebraska be revised so as to coincide with the east and south section lines of the subject section as shown by the dark lines circled and identified on Exhibit A. Hooper filed a copy of a letter received by Hooper from Northeast agreeing to the proposed boundary shift.

There will be no duplication of facilities nor will Northeast be impeded in its ability to serve its remaining subscribers. There does not appear to be any economic impairment since Hooper was serving the area in question already.

Upon consideration of the surrounding circumstances and being fully advised, the Commission is of the opinion and finds that a boundary has been agreed upon by the parties which will eliminate a boundary error and prevent duplicate service from occurring. Both companies should be ordered to file revised service area maps showing the area in question (see Exhibit A) to be in the Hooper exchange of the Hooper Telephone Company.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that a boundary, as determined in Application No. C-933 and conforming to the service area identified in Exhibit A, be drawn which places said service area within the Hooper exchange of the Hooper Telephone Company.

IT IS FURTHER ORDERED that revised service area maps be filed by the Hooper Telephone Company and Northeast Nebraska Telephone Company showing the area in question to be in the Hooper exchange of the Hooper Telephone Company.

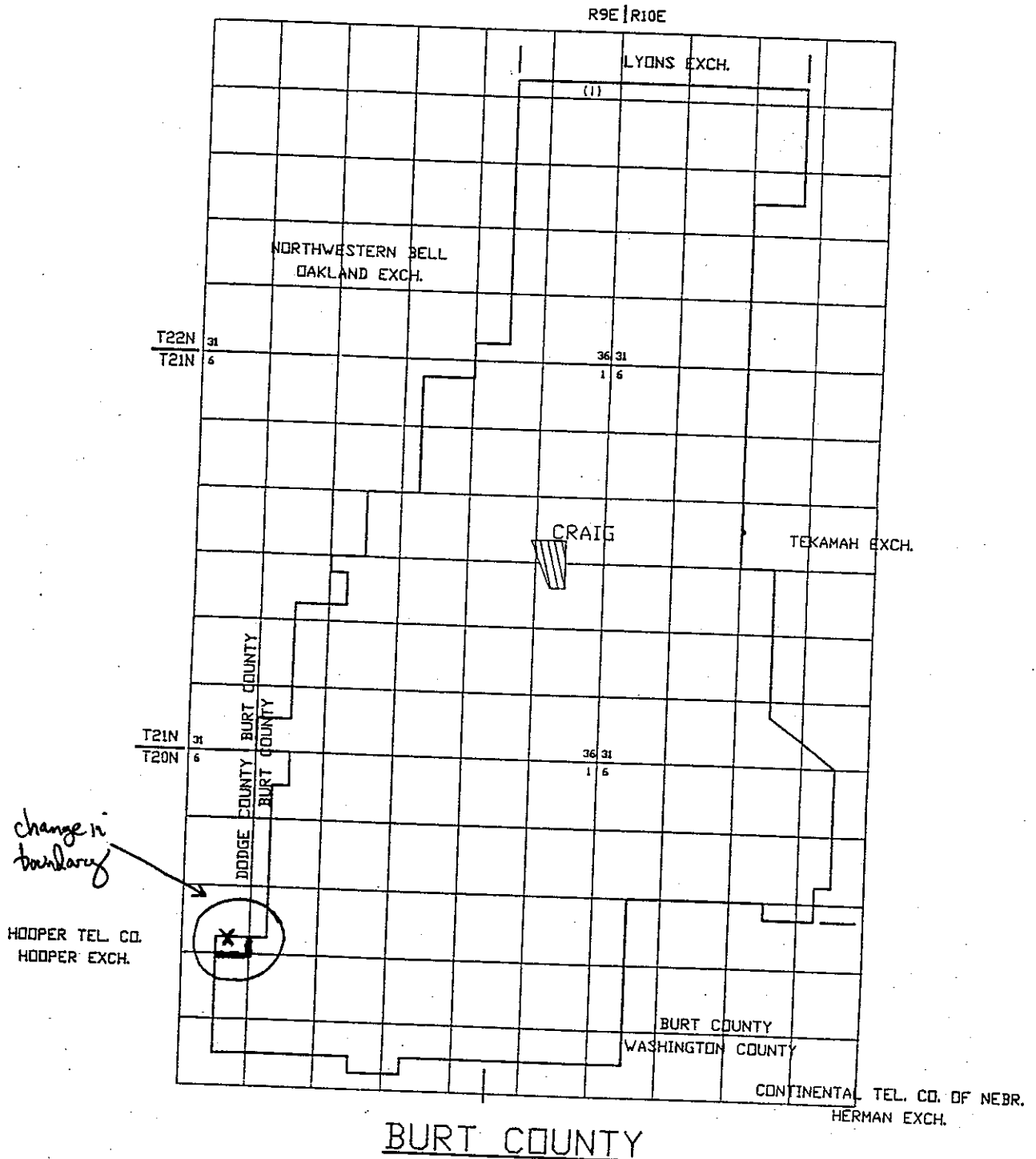
