O P I N I O N A N D F I N D I N G S

Hamilton Telephone Company (Hamilton) filed this application August 26, 1992 in response to a request from Ronald Klute of Hampton, Nebraska who wishes to receive telephone service from Hamilton. Klute currently receives service from the Bradshaw exchange of Lincoln Telephone Company, Lincoln, Nebraska. Notice of the application was filed in the Omaha Daily Record August 28, 1992. No protests to the application were received.

In support of the application, Hamilton filed three exhibits. Exhibit A is the letter from Klute requesting service. Exhibit B shows the affected area on a portion of Hamilton's Hampton exchange boundary map and Exhibit C is a letter from Lincoln Telephone's representative agreeing to release Klute to the Hampton exchange provided Klute pays an abandonment cost of \$553. Klute's letter includes a provision stating he so agrees to pay that amount. Since there is no dispute, and an affidavit has been filed in accordance with the Commission's modified procedure rule, this application will be handled this date absent a hearing.

Upon consideration of the application, the supporting affidavits and exhibits, and being fully advised, the Commission is of the opinion and finds that a boundary has been agreed upon by all parties which will place the Ronald Klute property in the Hampton exchange of the Hamilton Telephone Company upon payment of a \$553 abandonment fee to Lincoln Telephone Company. Both companies should be ordered to file revised service area maps showing the area in question to be in the Hampton exchange of Hamilton Telephone Company.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that a boundary be, and it is hereby, determined in Application No. C-946 to place the Ronald Klute property in the Hampton exchange of the Hamilton Telephone Company as reflected by Exhibit B of the application.

IT IS FURTHER ORDERED that revised service area maps be filed by Hamilton Telephone Company and by the Lincoln Tele-
