O P I N I O N   A N D   F I N D I N G S

By its application filed October 26, 1992, International Telecharge, Inc. ("ITI") of Dallas, Texas seeks to amend its certificate to reflect a name change to "International Telecharge, Inc. d/b/a ONCOR Communications, Inc."

Notice of the application was published November 4, 1992 in the Omaha Daily Record per the Commission's procedural rules. No one protested the application.

The applicant was granted a certificate to provide interLATA interexchange resale of telecommunications services in Nebraska August 9, 1988 in Application No. C-745. On July 1, 1992, ITI entered into a Sales, Accounting and Management Services Agreement with ONCOR Communications, Inc. ("ONCOR"). ONCOR is a Delaware corporation wholly owned by Ronald J. Haan. Haan has de facto control of ITI and, through a company called Long Distance Communications, Inc., is also effecting overall control of ITI through the purchase of it's outstanding stock. As part of the consolidation of ITI and ONCOR, ONCOR may, pursuant to the agreement, provide ITI with certain financing and will provide ITI with management and related services. ITI will, in turn, use ONCOR's name in its interstate and, of more concern to us, intrastate operations.

With its application, ITI has included an updated tariff which reflects the name change sought, assuming the Commission grants the application. ITI has also provided a copy of the Assignment and License of Trademark, Service Mark, and Trade Name (see Exhibit B) and a copy of ONCOR's certificate to do business in Nebraska as a foreign corporation (see Exhibit C).

As a result of the above-described transaction, Applicant now petitions the Commission to officially recognize it as "International Telecharge, Inc. d/b/a ONCOR Communications, Inc." while continuing to do business in Nebraska pursuant to the authority granted to it in Application No. C-745.

Upon consideration of the application and being fully advised, the Commission is of the opinion and finds that the application is

reasonable, is in the public interest, and should be granted. If new articles of incorporation are filed reflecting the name change, a copy should be filed with the Commission for placement in this docket as well as Docket No. C-745. The tariff on file for the applicant should also reflect the name change.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-957 be, and it is hereby, granted. With the name change, the corporate entity holding the authority originally granted in Application No. C-745 shall hereinafter be recognized as "International Telecharge, Inc. d/b/a ONCOR Communications, Inc."

IT IS FURTHER ORDERED that this order shall also be filed in Docket No. C-745 and that docket shall remain in effect as regards the authority issued to the corporate entity subject to this order.

IT IS FINALLY ORDERED that the tariff filed by the Applicant with the application and reflecting the name change be, and it is hereby, the official tariff of the Applicant. Amendment of the official tariff shall hereinafter reflect the effect of this order. If a new articles of incorporation are filed reflecting the name change, a copy of said articles shall be filed with this Commission.
