BY THE COMMISSION

This application was jointly filed August 9, 1993 by Call Home America, Inc. ("CHA") of Austin, Texas and Allnet Communications Services, Inc. ("Allnet") of Birmingham, Michigan. The applicants seek the Commission's approval for the transfer of Call Home America's name, trademarks, service marks and customer base of its resale inbound 1-800 telecommunications business in Nebraska to Allnet. There is no transfer of franchises, certificates, permits or operative rights in this appli-If the application is granted, CHA will no longer offer services in Nebraska. CHA is currently authorized to provide interLATA and intraLATA interexchange telecommunications services within the State of Nebraska as granted to it in Application No. C-948 (January 5, 1993). Allnet holds the same type of authority which was granted to it in Application No. C-772 (August 1, 1989).

The applicants have executed an Asset Purchase Agreement to initiate the transaction described above. The effective date of the transfer of CHA's rights in and to each customer account to Allnet has been agreed by the parties to be the date on which this application is approved by this Commission. In the interim between the filing of the application and the issu-

ance of an order, CHA has continued to provide inbound 1-800 services to all its customers. Upon acquisition, Allnet will designate in its tariff the subject service as "Call Home America." Therefore, the transfer of the inbound 1-800 service from CHA to Allnet will be virtually transparent to CHA's customers.

Upon the approval of the application, CHA seeks that its tariff be cancelled since it will no longer offer service in Nebraska. Since CHA will no longer operate in Nebraska and because the Commission does not allow dormant certificates of authority to remain in effect, we will revoke the certificate previously granted in Application No. C-948 and Call Home America will have no operating authority in this State.

There are no complaints pending against CHA or against Allnet in Nebraska. Approval of the above-described transaction does not appear to alter or adversely affect the current CHA customers in Nebraska.

The application is fair and reasonable; approval is in the interest of the public, CHA's current customers, CHA, and Allnet. The application should be granted. The order previously granting CHA authority should be revoked.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-1020 be, and it is hereby, granted. The Call Home America, Inc. intrastate operating authority previously granted in Application No. C-948 is hereby revoked. This order does not add any additional operating authority to Allnet Communication Services, Inc.

IT IS FURTHER ORDERED that the two applicants complete the necessary transactions contemplated to carry out this order.

IT IS FURTHER ORDERED that Allnet Communication Services, Inc. shall continue to file, in accordance with the applicable statutes, an annual report with this Commission consisting of (a) a copy of any report filed with the Federal Communications Commission, (b) the annual report to stockholders, and (c) for the State of Nebraska on a combined interstate-intrastate basis, the investment in telephone plant and equipment located within the state, accumulated depreciation thereon, operating revenues, operating expenses, and taxes.

IT IS FURTHER ORDERED that Allnet Communication Services, Inc. file an amended tariff with the Commission to reflect any services to be offered after the completion of the transaction between the applicants not found in its current tariff.
