O P I N I O N   A N D   F I N D I N G S

On June 10, 1994, M. Gene Hand, Director of the Communications Department in the Nebraska Public Service Commission petitioned the Commission to set a hearing in the matter against Overlooked Opinions, of Chicago, Illinois, as it appeared that the Defendant was operating as a reseller of telecommunications services in Nebraska without a Certificate of Public Convenience and Necessity.

The Communications Department requested the Defendant to provide the Commission with information including, but not limited to its sales materials and telemarketing scripts, customer contracts, an explanation of the arrangement with the underlying carrier, and a listing of rates the company charges.

The Commission received the pertinent information on August 5, 1994. The material explained that the Defendant markets calls for Amerifax, Inc., dba AmeriConnect, a Nebraska certified reseller. The sample customer bill and the contract to establish telecommunications service displays AmeriConnect's name. The Defendant does not offer telecommunications services to the public, thus a Certificate of Convenience is not necessary.

The Defendant advised the Commission that the company is in the process of changing its corporate structure. We take this opportunity to advise the Defendant and its officers and directors that any changes in marketing should be brought to the attention of the Commission. If Overlooked Opinions desires to become a reseller of telecommunications in the future, a proper certificate must be obtained prior to offering service.

1. The Defendant is not currently a reseller of telecommunications services in Nebraska.
2. Docket C-1080 / Departmental Complaint 008 should be dismissed.
