BY THE COMMISSION

The Commission enters this order nunc pro tunc to correct the order previously issued in C-1142 on April 4, 1995. That order approved the applicant, Communications Central, Inc., d/b/a Invision, Inc. to operate as a resale common carrier of telecommunications services within the state of Nebraska. The order contains an error which was brought to the Commission's attention by the applicant's local legal counsel on April 13, 1995.

The purpose of an order nunc pro tunc is to correct the record which has been made so that it will truly record the action taken which, through inadvertence or mistake, was not truly recorded. <u>Interstate Printing Co. v. Dept. of Revenue</u>, 236 Neb. 110, 459 N.W.2d 519 (1990). Clerical errors may be corrected by an order nunc pro tunc, but not judicial errors. <u>Larson v. Bedke</u>, 211 Neb. 247, 318 N.W.2d 253 (1982).

The order entered by the Commission on April 4, 1995 authorizes Communications Central, Inc., d/b/a Invision, Inc. to obtain a certificate of public convenience and necessity to operate as a reseller of intrastate telecommunications services in Nebraska. The operating name, Invision, Inc., is in error and should be corrected. The correct name that Communications Central will be utilizing is Invision Telecom, Inc.

After examining the record, and being fully advised, the Commission finds that the April 4, 1995 order does not accurately reflect the operating name of the applicant. Therefore, the Commission should issue an order nunc pro tunc to correct the original order.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the previous order granted in Application No. C-1142 on April 4, 1995 be amended by this order nunc pro tunc to reflect that the certificate of public convenience and necessity granted to Communications Central, Inc., d/b/a Invision, Inc. be and it is hereby altered to authorize Communications Central, Inc., d/b/a Invision Telecom, Inc. to operate as a resale carrier of intrastate interexchange
