PRELIMINARY MATTERS

On June 22, 1995, an application was filed by International Telecommunications Exchange Corporation (INTEX), of Atlanta, Georgia and Corporate Telemanagement Group (CTG), of South Carolina, for authority to transfer assets from INTEX to CTG. Notice of the application was published in the Omaha Daily Record on June 26, 1995. No protests were received; therefore, we will process this application pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

INTEX obtained a Certificate of Public Convenience and Necessity from the Commission pursuant to Application C-962 on February 23, 1993. No departmental or formal complaints have been filed against the company since its certification.

CTG is a South Carolina corporation with its principal place of business in Greenville, South Carolina. The Commission granted CTG a Certificate of Public Convenience and Necessity in Application C-932 on September 1, 1992 to provide intraLATA and interLATA services. Like INTEX, no formal or departmental complaints have been filed against the company.

INTEX has agreed to convey a portion of its assets to CTG, specifically (a) all contracts, rights, lists records, billing and other customer information relating to INTEX's customers; (b) all sales agents' contracts, rights, lists, records, payment and other information regarding sales agents; and (c) all trademarks, copyrights, tradenames, corporate names, patents, licenses, telephone numbers and listing, and any other intangible assets including leases and contracts. The agreement is effective the date the Commission approves the authority sought herein.

INTEX will discontinue service to its Nebraska customers; therefore, the company does not need its certification or tariff to remain active. CTG anticipates a transition period of approximately, six month to fully integrate INTEX's customers into its operations. Therefore, the Certificate of Public Convenience and Necessity granted to INTEX will expire on December 31, 1995.

CTG will initially bill the INTEX customers under the INTEX tariff; however, CTG will ultimately bill the customers under its own rates, terms and condition. Customers are being notified in advance regarding the change in their long distance provider and of their opportunity to select the carrier of their choice.

Upon consideration of the application, the governing statutes and rules, and being fully informed, the Commission is of the opinion and finds:

The transfer of assets belonging to INTEX of Atlanta, Georgia to CTG of Greenville, South Carolina is fair and reasonable, is in the public interest and should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application C-1204 be, and it is hereby granted the assets of International Telecommunications Exchange Corporation is hereby transferred to Corporate Telemanagement Group whereby Corporate Telemanagement Group is authorized to operate as a resale carrier of intrastate interexchange interLATA and intraLATA telecommunications services within the state of Nebraska.

IT IS FURTHER ORDERED that INTEX shall file for the year 1995, in accordance with the applicable statutes, an annual report with this Commission consisting of (a) a copy of any report filed with the Federal Communications Commission, (b) the annual report to stockholders, and (c) for the State of Nebraska on a combined interstate-intrastate basis, the investment in telephone plant and equipment located within the state, accumulated depreciation thereon, operating revenues, expenses and taxes by April 30, 1996.

IT IS FURTHER ORDERED that the Certificate of Public Convenience and Necessity granted to INTEX will expire on December 31, 1995.

IT IS FURTHER ORDERED that CTG shall continue to file, in accordance with the applicable statutes, an annual report with this Commission consisting of (a) a copy of any report filed with the Federal Communications Commission, (b) the annual report to stockholders, and (c) for the State of Nebraska on a combined interstate-intrastate basis, the investment in telephone plant and equipment located within the state, accumulated depreciation thereon, operating revenues, expenses and taxes.
